***Mode of Bid Security Deposit.**

- The bidder has a choice for depositing the Bid Security either 100% through "On Line Payment" mode or 100% in the form of Bank Guarantee from any nationalized / Scheduled Bank, valid up to period of 6 (six) months from the date, or extended date of opening of bid, whichever is later.

- The bidders should also note that the tender fee Rs. 1000/- and RISL fee Rs. 1000/- will be accepted through "on-line payment" mode only as already mentioned in the bid documents.

Note:

1. Bidder (authorised signatory) shall submit their offer on-line in Electronic formats both for technical and financial proposal.
2. In case, any of the bidders fails to pay the Tender Fee, BSD, and RISL Processing Fee, online (subject to confirmation), its Bid shall not be accepted.
3. To participate in online bidding process, Bidders must procure a Digital Signature Certificate (Type III) as per Information Technology Act-2000 using which they can digitally sign their electronic bids.
