## JAIPUR DEVELOPMENT AUTHORITY, JAIPUR Special Terms & Conditions for Eligibility Criteria

- ➤ The firm must have experience of 3 years for the maintenance of 2500 lights per months.
- The firm must have a single order of the 50% of the tender amount in any one of last 03 years for street light maintenance.
- The firm must produce the ownership/contract for hoist/crane up to 10 Mtr. height.
- After order, the firm will restore/replace all accessories within 2 months and prepare an inventory.
- After completion of the contract period, firm will hand over the system in working condition to the next incoming contractor along with complete inventory as above.
- The contractor will have to establish a control center/ office at JDA premises with computer set and 2 phone numbers during working hours.
- The complaint rectification time will be maximum 48 hours. If more than 95% of lights of a particular section/road is working then there will be no penalty, if 90%-95% lights is working then Rs. 100 per light/per day shall be charged for lights not working and if 80%-90% light is working then Rs. 200 per light/per day shall be charged for lights not working and if 60%-80% lights is working then Rs. 300 per light/per day shall be charged for light not working. If less than 60% light are found working only, the work will be withdrawn raising a week notice. If the performance of the firm is not found satisfactory after raising a week notice, the contract may be terminated with forfeiture of EMD and if the firm quits the work during contract period deliberately, the EMD shall be forfeited and the firm will be black-listed. In this regard the decision of JDA will be final.
- The scope of work covers the areas in JDA region like vatika road, chandlai, Neemeda road, kalwar road, Mahindra Sez area, Muhana, BSF Camp labana Delhi road, Naradpura Agra road, Anandlok, Underpass, Ring road, Ajmer road, Todi mod, Bassi, Goner village, near dadi ka phatak, Bagru and other areas as per Enginer-incharge.
- The quantity/ number of lights in tender is tentative. If may exceed and decrease as per site situation.
- The firm will ensure the lights "on timing", is kept as half an hour before sunset and lights "off timing", is kept as half an hour after sunrises to minimize the electric bill.
- It will be the responsibility of the firm to protect the JVVNL, meters and he will keep record of meter reading and fault in the system.
- Keeping in view the number of lights spread over large area, the firm will keep sufficient number of teams for fault rectification.
- All the items/equipment's used for maintenance purpose shall be of Group-I standard of JDA Elect. BSR 2016.

NOTE:- The tender will be single bid 2 envelop system (Technical & Financial Bid). The firm have to submit supporting documents for (Eligibility Criteria) conditions and for rest conditions he will have to agree with proper signature and seal in envelop no. 1. Envelop no. 2 containing rates, will be opened only of those agencies, who will fulfill the conditions in envelop no. 1.
