		You have given in Special Condition of Contract that the bidder should submit the undertaking that the bidder have not Blacklisted or Rescinded by the client in last 10 Years but in RTPP Annexure A you given that the bidder have not debarred in last 3 Years. Additional information from JDA's side:-

- 1. The steel strands are to be procured from TATA plant and reinforcement steel is to be procured from primary manufacturers like TATA, SAIL, RINL etc. only as approved by EIC.
- 2. Expansion Joints, Bearings, Stressing material etc. are to be procured from vendors which are to be got approved from EIC before procurement. Vendors should be fulfilled all the criteria of MoRTH Specifications.
- 3. The bidder will have to get fabrication of composite girder for Railway Span as per RDSO design and drawing and approved vendor by RDSO. All tests will for works under Railway span will have to conduct as per satisfaction of the NWR. No extra cost will be paid on this account. Sacrificial Shuttering will be paid separately.
- 4. The design of RE wall and its facia panels will have to be got approved and vetted by IIT prior to execution of work.
- 5. The bidders are requested to fill all the details of Bid document properly especially the RTPP annexure A, B, C, and D failing which Bid may be rejected.
- 6. The bidders are requested to pay special attention towards Section-7. Special condition of contract for safety, health and environment (SHE) and the related penalty clause.
- 7. The bidders are requested to pay special attention towards the liquidated damages clause 3.12.2 of OCC at page no.130 wherein mile stones have been defined and liquidated damages have been proposed for not achieving key dates, not mobilizing required machinery and for not installing requisite number of casting beds for PSC girders.
- 8. The bidders are requested to pay proper attention towards clause No. 3.7.4h at page No.128 for Corporate Social Responsibilities CSR. However, the DLP shall be 1 year for this part of work.
- 9. The design of staging shall have to be got proof checked by MNIT or any other MORTH empanelled consultant before execution of work for which no extra payment will be made.
- 10. The PMB grade of bitumen shall be procured from HINCOL, OOMS, TOTAL or equivalent as approved by EIC.
- 11. All the applicable permits/NOC's/Traffic diversion permission shall have to be arrange and borne by the bidder at their own cost. However JDA may assist in obtaining such permissions/NOC. Any delay in obtaining such permits/NOC shall not be considered for delay in works as per agreement.

- 12. Any damages of the utilities and underground services, during execution of work caused by contractor/machinery/labour will have to be restored by the bidder at his own cost for which no extra payment shall be made.
- 13. Bidder should submit on the date of downloading of the bid documents, the documentary proof of Tax Registration Certificate. Works Executed photocopies of completion / execution certificate issued by an officer not below the rank of Executive Engineer giving detail of contract including date of start, date of completion, amount of work done, nature of work etc.) and turnover of above pre-qualification requirement.
- 14. The rates quoted by the bidder should be inclusive of all the taxes.
- 15. All measurement and payment will be done as per MORTH specifications.
- 16. Contractor shall arrange for Span load testing by NIT/IIT as per MoRTH Specification. The IIT/NIT proof checking fees and all other arrangements as needed by IIT/NIT shall be provided by the bidder and nothing extra payment shall be given for the same.
- 17. Approximately 9% work of whole bridge is done by previous agency, which is not included in new 'G' Schedule.

The minutes of the pre bid meeting will henceforth become the part of bid document.
